Pursuant to the provisions of the Companies (Amendment) Act, 2017, notified by the Ministry of Corporate Affairs and effective from 7th May 2018, the requirement of ratification of the Statutory Auditors' appointment at every subsequent AGM has been omitted. Accordingly, no resolution is being proposed at this AGM for ratification of their appointment.

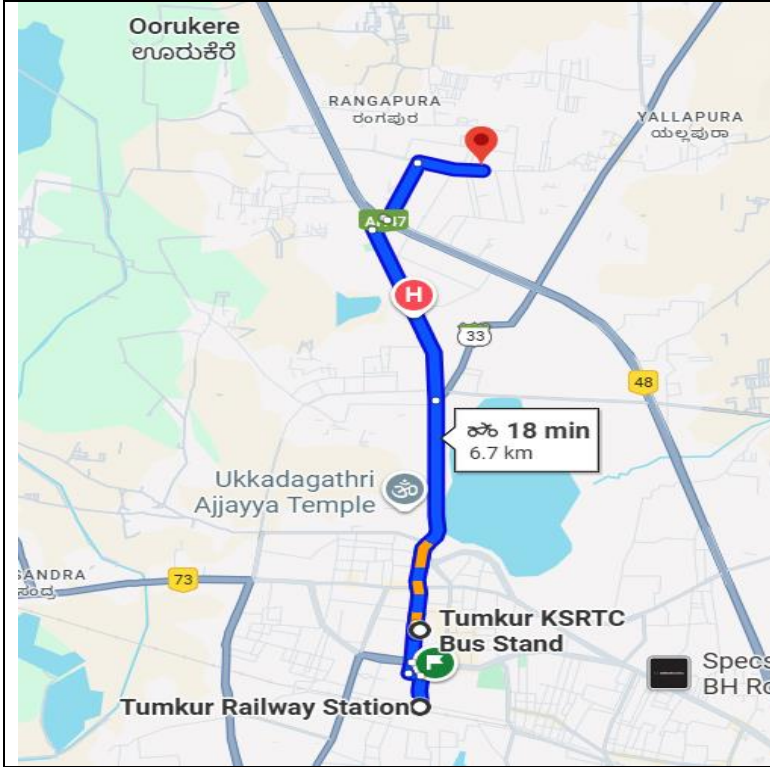
